G.S.R. 21.—In exercise of the powers conferred by the proviso to article 309 of the Constitution and the supercession of the Data Processing division and survey Design and Research Division, National Sample Survey Organisation, Ministry of Statistics and Programme implementation (Accounts-cum-Administrative Officer and Office Superintendent) Recruitment Rules, 1994, except as respects things done or omitted to be done before such supercession, the President hereby makes the following rules regulating the method of recruitment to the posts of Accounts-

Accounts-cum-Administrative Officer and Office Superintendent in the Data Processing Division and Survey Design and Research Division, National Sample Survey Organisation, Ministry of Statistics and Programme Implementation, namely :—

Short title and commencement.—(1) These rules may be called the Data Processing Division and Survey Design and Research Division, National Sample Survey Organisation. (Accounts-cum-Administrative Officer and Office Superintendent) Recruitment Rules, 2008.

(2) They shall come into force on the date of their publication in the Official Gazette.

Application.—These rules shall apply to posts specified in column (1) of the Schedule annexed to these rules.

Number of posts, classification and scale of pay.—The number of the said posts, their classification and the scale of pay attached thereto shall be as specified in columns (2) to (4) of the said Schedule.

Method of recruitment, age limit and other qualifications, etc.—The method of recruitment, age limit, educational qualifications and other matters relating thereto shall be as specified in columns (5) to (14) of the afore said Schedule.

Disqualifications.—No person,—

- (a) who has entered into or contracted a marriage with a person having a spouse living; or
- (b) who, having a spouse living, has entered into or contracted a marriage with any person,

shall be eligible for appointment to the said post :

Provided that the Central Government may, if satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and that there are other grounds for so doing, exempt any person from the operation of this rule.

6. Power to relax.—Where the Central Government is of the opinion that it is necessary or expedient so to do, it may, by order, for reasons to be recorded in writing, in consultation with the Union Public Service Commission relax any of the provisions of these rules with respect to any class or category of persons.

7. Saving.—Nothing in these rules shall affect reservations, relaxation of age limit and other concessions required to be provided for the Scheduled Castes, the Scheduled Tribes, and other special categories of persons in accordance with the orders issued by the Central Government from time to time in this regard.

(ii) with three years regular service in the posts in the scale of Rs. 5500-9000 or equivalent;

AND

(b) having five years experience in the Establishment, Budget and Cash & Accounts work. The Departmental Officers in the feeder category who are in the direct line of promotion shall not be eligible for consideration for appointment of deputation.

Similarly, deputationist shall not be eligible for consideration for appointment by promotion.

(Period of deputation including period of deputation in another ex-cadre post held immediately preceding this appointment in the same or some other organization or department of the Central Government shall ordinarily not exceed three years. The maximum age limit for appointment by transfer of deputation shall be not exceeding 56 years as on the closing date of the receipt of applications).
